Dear MAJ Simon Sanchez,

In accordance with Army Regulation (AR) 210-22 and Army in Europe Regulation (AER) 210-22, International Information Systems Security Certification Consortium (ISC)² is authorized to operate as a private organization (PO) on the installations and within areas under the control of USAG Wiesbaden. This approval is valid for a period of two years from the above date. A renewal request must be received no later than 90 days prior to the expiration and contain the following:

- a. Two copies of the current constitution, bylaws, and articles of government signed by the president and one other member (only if any revisions or amendments have been made).
 - b. A completed copy of the "Constitution and Bylaws" checklist.
- c. A list of current officers to include names, SOFA status, addresses, email addresses and telephone numbers.
- d. A copy of audit(s) for the past two years with appropriate responses, if applicable.
 - e. Changes to the organization and its operations, if applicable.
 - f. The location and types of on-post bank accounts and the account numbers.
- g. Proof of insurance and bonding or a copy of any insurance policy covering the PO's activities or a statement from a parent organization indicating that its policy covers the local organization.
 - h. A copy of the approval document if approval to operate was granted previously.
- i. The percentage of PO members with SOFA status. A current list of the members and their SOFA status meets this requirement.

This approval does not constitute an obligation on the part of the Department of the Army for any liabilities incurred by your PO. All liabilities are the sole responsibility of the PO and/or its members.

This approval authorizes your organization the use of military banking and limited mail delivery services. In accordance with AER 210-22, "The Intratheater Delivery System (IDS) authorization includes no-cost delivery of correspondence weighing 13 ounces or less and parcels weighing 70 pounds or less when the item is sent from one APO address to another within USEUCOM. It does not extend to items originating from or terminating in the continental United States. The IDS may not be used for business or commercial purposes or for transactions involving items for resale. POs will print, type, or stamp "PO" in the upper-right corner on correspondence and parcels. POs are not authorized to use official Government mail items or services. POs may not use the USPS (APO)."

"Postal privileges are approved only for correspondence within the USEUCOM area as detailed in AER 210-22 para. 10."

This authorization expires two years from the date above unless an approval is given to request for renewal.
